Borough of Baldwin Community Swimming Pool Membership Agreement

By purchasing a 2021 season pass, you agree to abide by the following rules and regulations to ensure the safety and enjoyment of all.

1. Pool passes must be presented and scanned to gain entry to the pool.
2. Obey lifeguard instructions at all times.
3. A child under 52 inches must be accompanied by an adult (within arm's reach) at all times when using the swimming pool or wear a lifejacket.
4. Do not run on the swimming pool deck.
5. Refrain from unsafe behavior for the safety and enjoyment of all swimmers.
6. Obey deck and attraction signs where posted.
7. Evacuate swimming pool immediately when horn alarm sounds.
8. Glass containers, littering, smoking, and alcohol are not permitted.
9. Swimmers must wear appropriate swim attire at all times.
10. Swim diapers must be worn in the pool by all children who are not toilet-trained. Disposable swimming diapers may be purchased at the pool office for your convenience.
11. The Borough is not responsible for lost or stolen items.
12. No refunds for inclement weather.
13. Persons who appear to be under the influence of alcohol or narcotics will be denied admission.
14. Spitting, urinating, and nose-blowing are prohibited in the pool.
15. You will be verbally warned if you disobey any of the rules and regulations above. You will be escorted out of the pool facility if you continue to break the rules. Repeated offenses across multiple visits may result in the suspension of your season pass without a refund.

Borough of Baldwin Community Swimming Pool Registration Waiver & Privacy Policy

In consideration of being permitted to participate in the Borough of Baldwin Community Pool facility activities ("Activity") I, for myself and/or for my minor child:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of such activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.
2. FULLY UNDERSTAND THAT: (a) Swimming Pool activities involve risks and dangers of serious bodily injury ("Risks"); (b) these Risks and dangers may be caused by my own actions or inaction's, the actions or inaction's of others participating in the Activity, or the condition in which the Activity takes place; (c) I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.
3. AGREE to assume legal liability of participating in the Activity, and waive and release all claims for injuries, damages, or loss which you or your minor child might sustain as a result of participating in any and all activities connected with and associated with this facility.

The Borough of Baldwin, which uses eSoft Planner for tracking season passes, is committed to protecting your privacy.

Uses of your personal information: Personal information is any information that can be used to identify an individual, and may include, but is not limited to, name, email address, postal or other physical address, and other information required to provide a service or carry out a transaction you have requested. We will only use your personal information in the way we specified when it was collected. We will not subsequently change the way your personal information is used without your consent.

Security of your personal information: Baldwin Borough and eSoft is committed to protecting the personal information you share with us. We utilize a combination of security technologies, procedures, and organizational measures to protect your information from unauthorized access, use or disclosure.

Data retention: Baldwin Borough and eSoft will not retain your personal information longer than is necessary to fulfill the purposes for which it was collected or as required by applicable laws or regulations.
